#### 1. Definitions

"Footage Bazaar," "we," "our," or "us" refers to the company operating the platforms footagebazaar.in and footagebazaar.com. "Contributor" refers to a user who uploads videos, footage, or other digital media ("Content") to Footage Bazaar for sale or licensing. ## 2. Ownership and Copyright

Footage Bazaar acts solely as a licensing intermediary and does not claim ownership of Contributor Content. ## 3. Royalties and Payments

Contributors receive 50% of the net revenue (after applicable payment gateway fees, taxes, and charges) from each sale or license of their Content. Royalties are calculated monthly and communicated to Contributors on the 30th of each month. Payments are made through bank transfer, UPI, or other supported methods, subject to reaching the minimum payout threshold. Contributors are responsible for providing accurate payment details. Footage Bazaar is not responsible for delays due to incorrect or incomplete information.

# 4. Content Submission and Approval

Contributors may upload only original Content they have full rights to license. Footage Bazaar reserves the right to review, approve, reject, or remove Content that violates these Terms, or that is deemed unsuitable for licensing. Content found to violate intellectual property laws may be permanently removed, and the associated account may be

suspended or terminated.

## 5. Customer Purchases and Licensing

Customers can purchase licenses using UPI, credit/debit cards, NEFT, or other payment gateways provided on the Website. Upon successful payment, Customers receive a non-exclusive, non-transferable license to use the purchased Content in accordance with the license terms. All sales are final.
